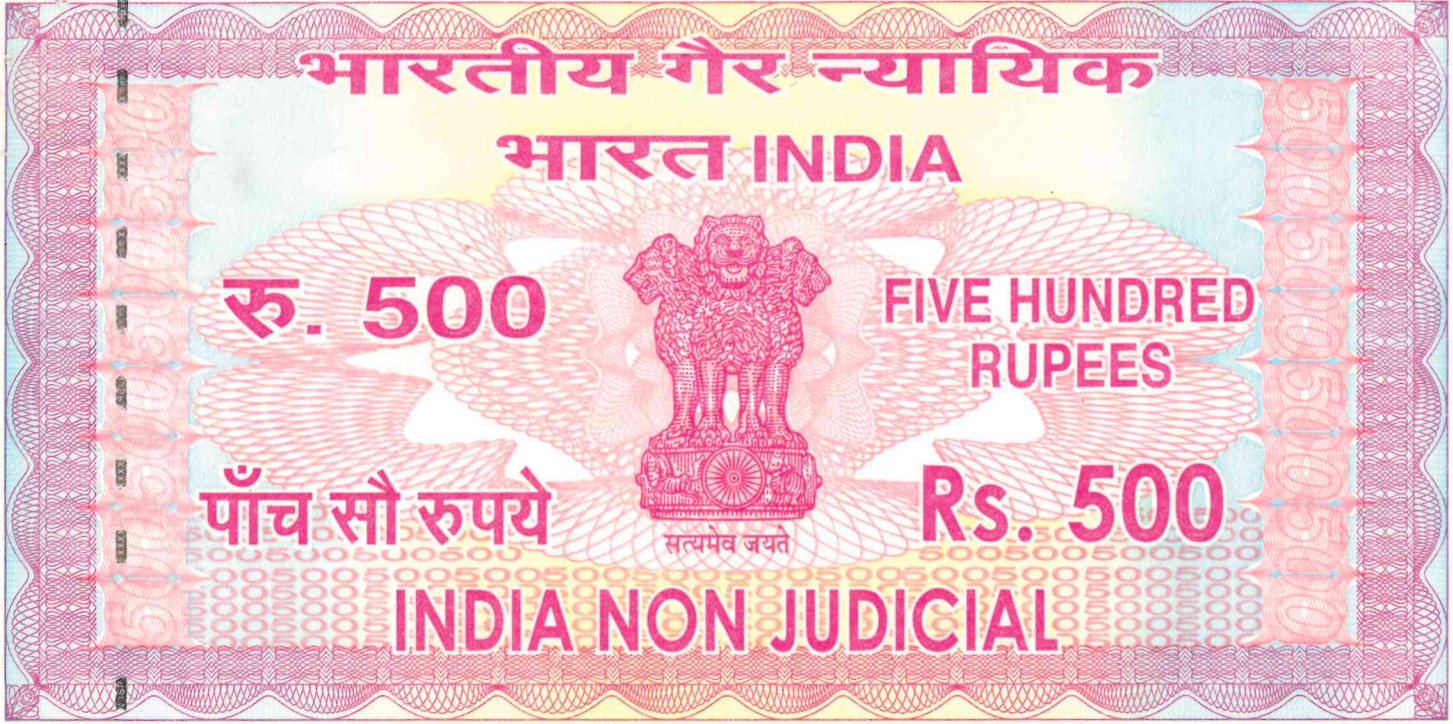

**AND WHEREAS** the founder trustee/s hereto have accepted the said trust and agreed to manage and administer the same on the Regulations hereinafter mentioned in this deed;

**NOW THIS TRUST DEED WITNESSETH AS FOLLOWS:**

1. This trust deed shall be deemed to have come into effect from the Wednesday, the 7th day of December 2022 ;

**2. NAME OF THE TRUST**

The trust is a public charitable trust and shall be designated as “ VB TRUST ” or any other name as the trustees may be desired from time to time;

**3. REGISTERED OFFICE**

The registered office of the trust shall be at 2/65, North St, Periyanesalur, Veppur TK, Cuddalore Dt – 606 304 and or at such other place/s as the trustees may desire from time to time;

**4. AIMS AND OBJECTS OF THE TRUST:**

- a) To establish, to take over or acquire and maintain and manage schools, colleges, and other educational institutions, orphanages, charitable organizations, etc.;
- b) To establish, maintain and manage hospitals, clinics, laboratories, blood banks and to provide the poor with medical aid;
- c) To award scholarships, stipends to students in India to enable them to pursuing their studies in India and for purchasing books, to award prizes to students for proficiency in any subject or languages;
- d) To promote study and research in any subject and afford facilities to those who conduct such study and research on any subject;
- e) To supply RO water (Purified) at the cheapest price to the poor and downtrodden people;

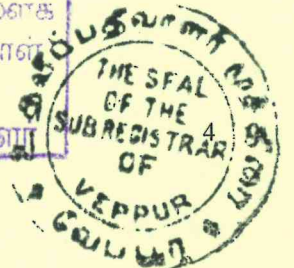




- f) The first and utmost requirement of this public Trust is that benefits the community at large irrespective of caste, creed, etc.;
- g) The Trustees may accept donations, grants, subscription, aids or contributions from any persons, Government, Local Authorities or any other charitable institutions in cash or any kind including immovable property without any encumbrance.
- h) To give financial or corporal aid or other help to deserving persons;
- i) To impart training for advancement of knowledge in any subject or language;
- j) To establish take over or acquire or maintain and manage crèches, homes for the old and disabled and orphanages;
- k) To give subscriptions or donations to any charitable institutions;
- l) To accept upon such terms and conditions as they shall think fit, any donations, grants, subscriptions, aid and contributions from any government, local authority, corporation, firm, company, syndicate, association, or other person or from any charitable or other institutions whether they shall be in cash or in other movable or immovable property for the purposes of the trust PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with or repugnant to the provisions contained in these presents and such donations, grants, aides, subscriptions and contributions shall be applied for all or any of the objects of the trust;
- m) To acquire by purchase, lease or otherwise any property whether movable or immovable or any rights for the purpose of the trust and to sell, give or lease, mortgage or otherwise transfer any such property or rights;
- n) To construct, maintain or alter any buildings or works necessary for the purpose of the trust;

- o) To borrow money for the purpose of the trust upon any terms and conditions;
- p) To take the socio-economic programme and for the betterment of women and children;
- q) To take up any rural development programme and or conduct the same;
- r) To receive grants from agencies including central board for the workers education to conduct programme for rural women;
- p) To promote, conduct, undertake all kinds of awareness programmes among the people;
- q) To conduct health programmes to check, diagnose, treat various contagious and non-contagious disease and vaccinations for different diseases free of cost;
- r) To conserve AIDS/HIV/TB control and AIDS awareness programmes, seminar, camp etc;
- s) To inform and educate the public regarding various Welfare and Development programmes sponsored by the Central and the State Government, Development for various sections of the society;
- t) To absorb, acquire, amalgamate, merge, collaborate, and takeover of existing Public Charitable and Educational Trusts and or Societies having similar objects with this trust for better achievement of its objects as above stated;
- u) To promote, conduct, conserve the environment and to provide sustainable development;
- v) To distribute medicines, food, clothes and all other goods during floods, earthquakes, fire, mass destruction of any kind etc.;
- w) To do all such other lawful things as may be considered incidental or conducive to the attainment of the objects mentioned above;

- v) Any Trustee other than founder trustee/s appointed shall hold office for a period of three years from the date of his nomination. The retiring trustee shall be eligible for reappointment;
- vi) Vacancies caused in the office of the trustees shall be filled up by the Chairman / Managing Trustee on the advice of the Board of Trustees by co-option only;

**7. RIGHTS OF THE CHAIRMAN AND MANAGING TRUSTEE**

- i) The Managing Trustee, after his death or his ceasing to be a Trustee for whatever may be any of the reason, the next Founder Trustee shall be appointed from the legal heirs of the Managing Trustee. If no legal heir is willing or available for appointment, the Managing Trustee shall be appointed among the other Board of Trustees, whom gets majority vote.

The office of the Secretary and Treasurer shall be treated as any vacancy in the Board and will be appointed among the other Board of Trustees.

- ii) Any Trustee other than founder trustee/s and First Trustees appointed shall hold office for a period of three years from the date of his nomination. The retiring trustee shall be eligible for reappointment automatically unless otherwise decided;
- iii) Vacancies caused in the office of the trustees shall be filled up by the Managing Trustee on the advice of the Board of Trustees by co-option only;

## 8 POWERS OF THE BOARD OF TRUSTEES

- a) The Board of trustees shall have all powers necessary or incidental for effectively carrying out the objects of the trust;
- b) Subject to general provisions of the trust and without prejudice to the general and specified powers conferred by the other provisions contained in THESE PRESENTS, the board of trustees shall have the following powers also:
- to apply the trust moneys to effectuate one object or some of the objects of the trust in preference to the other objects;
  - to discontinue the application of the trust funds to one object and divert the funds to another object;
  - to determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by the trust;
  - to extend the funds of the trust in such manner as they shall consider most beneficial for the purpose of the trust;
  - to acquire, build upon, pull down, rebuild and to alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises or property for the use of the trust;
  - to take any property on lease or hire;
  - to acquire any property;
  - to enter into any contract on behalf of the trust;
  - to borrow any money upon the security of any of the property of the trust and to grant mortgages for securing the same or without any security and upon such terms and conditions that the trustees may deem fit;

- x. to make and from time to time repeal or alter the rules and regulations as to a) the details of management of the trust and the affairs thereof or any Institutions under its control and also for Constitution and appointment of members for Managing Committee to run such institutions; b) as to the duties of the any officers or servants of the trust and c) as to the conduct or any of the matters or things within the powers or under the control of the board provided that the same shall not be inconsistent with the provisions contained in these presents;
- xi. to settle out of the court, compromise or compound all suits, actions and other proceedings and all differences or demands and to refer all or any of the such differences or demands to arbitration and to execute a releases and to settle and approve all accounts without being answerable for any loss occasioned thereby;
- xii. To appoint and dismiss managers, secretaries, clerks and other staff;

**9. POWERS OF THE CHAIRMAN / MANAGING TRUSTEE, SECRETARY AND TREASURER**

**(i) POWERS OF THE CHAIRMAN / MANAGING TRUSTEE**

- (a) The Chairman/Managing Trustee shall be the chief executive of the trust and the other organisations coming under the trust. His advice shall be final in all matters pertaining to the management. In the absence of the Chairman/Managing Trustee, the Secretary shall preside over and conduct all the meetings in a democratic manner;

**(ii) POWERS OF THE SECRETARY**

- a) The Secretary for the time being shall jointly with the Chairman / Managing Trustee be empowered subject to the approval of the Board of Trustees, to negotiate, execute and to do all other necessary documents to carry out all or any of the powers of the trust including the borrowings and shall do so for and on behalf of the trust only and any acts and deeds done in his personal capacity shall not bind the trust ;
- b) The secretary shall assist the Chairman / Managing Trustee in managing the affairs of the trust and the other organisations coming under the trust by convening the meetings, maintaining the records and registers;
- c) The secretary shall also be empowered to represent the trust before any Government, semi Government, banks, creditors and others;

**(iii) POWERS OF THE TREASURER**

- a) The Treasurer shall be in charge of receipts and payments, maintaining the accounts, arranging for audits, etc.;

**10. CUSTODY OF DOCUMENTS**

Title deeds, Investments and securities, Books of accounts and other Records and Registers belonging to the trust shall be in the permanent custody of the Chairman / Managing Trustee and shall open for inspection by any Trustee(s) on a reasonable notice to the Chairman / Managing Trustee ;

## 11. BANK ACCOUNT

(a) All income subscriptions and pecuniary donations for the general purpose of the trust and the income or investments and all other moneys from time to time forming part of the general revenue of the trust shall on the same being received be paid into an account with any nationalized or scheduled bank which the board may determine from time to time;

## 12. ACCOUNTS AND AUDIT

a) The Treasurer shall keep proper accounts of the trust. Income and expenditure, financial statements and balance sheet and other financial statements for every year as on the last date of 31<sup>st</sup> March shall be prepared and got signed by the Chairman/Managing Trustee and Secretary.

b) The accounts shall be got audited by a Chartered Accountant appointed by the board every year fixing his remuneration;

c) The Audited Accounts shall be placed before the Board of Trustees for approval and adoption within the time frame;

### 13. MEETINGS OF THE BOARD OF TRUSTEES

- a) The Trustees may meet together for dispatch of business and adjourn and otherwise regulate their meetings and proceedings as they think fit.
- b) 1/2 of the Board of Trustees present at the meeting shall be a quorum.
- c) Not less than one week notice shall be given in writing to of Trustees of every meeting of the Trustees.

### 14. TERMINATION

### 15. GENERAL

- a) The trust is **irrevocable** and any properties of the trust will never be revert back to the founder or to the trustees;
- b) The Income of the trust will be solely utilized towards the objects of the trust and that the funds or assets will not be utilized for payment to the author of the Trust / Institution / Trustee / Members by way of salary, remuneration, sitting fees, profit / interest / dividend, etc.;
- c) The income of the trust will be solely towards the objects and no portions of it shall be used for payments to the trustees by way of profit;

- f) No activities of the trust shall be carried out anywhere outside India;
- g) The trust shall not carry on any activity with the object of earning a profit;
- h) The seal of the trust shall bear the inscription "VB TRUST" and shall remain in the custody and control of the secretary;
- j) The trust hereby constituted fails for any reasons, the net assets of the trust shall be made over to any public charitable trust having objects similar to this trust and enjoying exemption u/s 11 and 80G of the Income tax Act, 1961, as may be resolved by the trustees;
- k) Not more than 5% of the income of the trust shall be applied for any religious purposes or given to any religious institution;

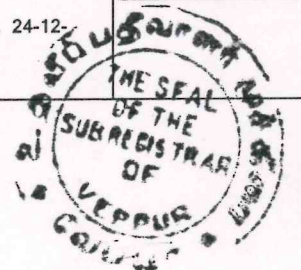


